- (1) Friends of the Branch PAC received three corporate contributions from MC companies in April, 2015. Campaign expenditures includes \$5000 contributions to each, Mike Bomgardner and John Norwood. This was the subject of a complaint to the Texas Ethics Commission resulting in a \$1,500 civil penalty to Friend of the Branch PAC June 22, 2018. The MC companies entered into an "agreement of voluntary compliance" in May, 2018.
- (2) MC refers to Mercer Crossing which was controlled by Gene Phillips and now partly by CADG Mercer Crossing, nominally an entity of Centurion American. However the combination of seller debt and the nature of the transaction indicates the seller is still substantially in control of the land.
